

Peace Officer/Special Investigator Scholarships

Available to Peace Officers and Special Investigators as defined herein:

- 1) Must be currently licensed and commissioned as a peace officer in accordance with the definitions contained in Article 2.12 or Article 2.121 of the Texas Code of Criminal Procedure
Or
- 2) Must be currently employed as a "special investigator" as defined in Article 2.122 of the Texas Code of Criminal Procedure.

Scholarship eligibility requirements:

- Currently employed as a peace officer or special investigator (as defined above)
- At least 12 months of continuous service as a commissioned/licensed peace officer or special investigator.
- Officer/Special Investigator must physically attend class (no distance ed or telecommuting)
- Maintain at least 2.25 cumulative GPA
- Complete required scholarship application each academic year
- Meet scholarship application deadlines
- Recipients must have been granted admission to TTU or TTUHSC
- Available to TTU graduates or undergraduates enrolled in a degree-seeking program and TTUHSC undergraduates enrolled in a degree-seeking program

NOTE: Texas Tech Police Department officers are eligible for the Employee Tuition Assistance Program and therefore will not need to apply for the Peace Officer/Special Investigator Scholarships.
